Thank you for your requesting the Visa. We can help you and guide with every step you need to take it.

Please send our Application Form by mail or e-mail, which will confirm your requests (a kind of visa, the date of departure, etc.) within two business days after getting your application.

- ① Since we will the set of applications, and the invoice by mail if you have the contents understood, please remit the visa fee by the due date.
- ② Please mail a set of documents which you need for the application by a visit or registered mail to our company (you'd better to send it by U-Pack of Japan post.)
- ③ We check the documents after your application arrival in our company, and start application procedure after checking payment.
- ④ We will return your passport by registered mail or Takkyubin after getting your visa.

*The acquirable scheduled day of your VISA will usually be about one week after arriving at our office. Please consult about those, as for, a margin is not in time in the case of an application.
